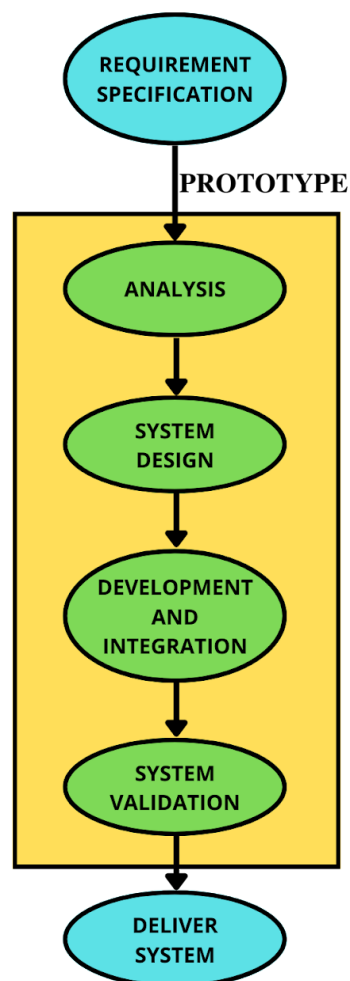


Figure 1. Hybrid of Evolutionary Prototyping and Reuse-oriented Development

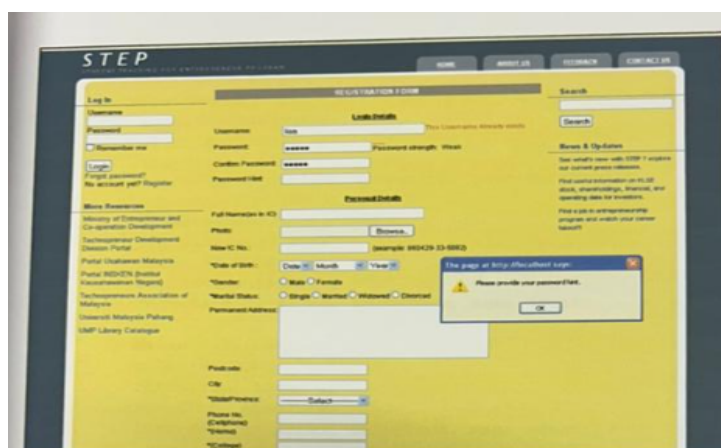


Figure 2. Registration Page in STEP
